The school will follow syllabi and courses as per scheme of studies prescribed by the Board for Secondary School Examination and changes made therein from time to time.

3. The school will enroll students proportionate to the facilities available in the school as prescribed in the Affiliation Bye-Laws of the Board which shall not in general exceed the optimum number as under:-



5. The school shall sponsor regularly its bonafide and eligible students in Board's class X Examination from the year mentioned above without break or inform with reasons thereof in writing well in time about the non-sponsoring of the candidates. Failure to do so will lead to suo moto withdrawal of the affiliation of the school for secondary Examination granted by the Board.

The school should not start Class XI/XII without written approval of the Board. The Board shall not be responsible for any consequences in case class XI/XII is started without following the Affiliation 6. Bye Laws and obtaining the prior approval of the Board.

The school shall appoint qualified and trained teaching staff on regular basis as per

provisions of Affiliation Bye Laws of the Board.

Service conditions, pay and allowances and other benefits to the employees of the school shall be at least at par with that of corresponding categories of employees S. working in Government Schools of the State in which the school is located. An undertaking to this effect be sent to C.B.S.E.

The school will apply for further Extension of Provisional Affiliation 'on online' through 25. www.cbseaff.nic.in with the prescribed fee of Rs. 12,500/- and other essential documents before 30th June of the preceding year before the expiry of the date of provisional affiliation.

The school is eligible to open CBSE pattern classes IX w.e.f. 01.04.2011. Accordingly, 1st Batch 26. of class X of the school will be appeared at the Board's Examination to be held in the year 2013.
